The Board of Directors of the Company has appointed Mrs. Palak Swapnil Desai, (Membership No. ACS: 16763; CP No.: 7426) as the Scrutinizer for conducting the postal ballot process in a fair and transparent manner.

- a) If you are already registered for e-Voting, then you can use your existing password to login and cast your vote.
- b) If you are using NSDL e-Voting system for the first time, you will need to retrieve the 'initial password' which was communicated to you. Once you retrieve your 'initial password', you need to enter the 'initial password' and the system will force you to change your password.
