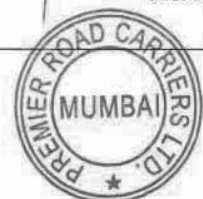

1. We have reviewed the accompanying statement of unaudited financial results ('the Statement') of PREMIER ROAD CARRIERS LIMITED ('the Company') for the quarter ended September 30, 2023, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), including relevant circulars issued by the SEBI from time to time.
